Rates and Fees of AYO Cards With Line of Credit

- 1. Debits and credits of AMD-denominated payments are subject to average exchange rate declared by the Central Bank of Armenia and prevailing on FX markets as of that date.
- 2. Currency in card transactions is exchanged at the rates specified in the Rules of Card Issuance and Usage, where VISA exchange rates include Ameriabank's fee of 2%.
- 3. All postal and telecommunication expenses, as well as third bank costs are charged additionally.
- 4. The Bank may review the fees and rates from time to time, in which case the Bank shall give notice to clients by ensuring that materials containing information about changes are available within the Bank's premises at all times or by posting the changes to the website of the Bank. Changes become effective on the date specified by the Bank, but in any case not earlier than client notice date.
- 5. All commissions taxable by VAT include VAT.
